Case Study - Situation

Aviation assets are leased and operated globally, spread across diverse operators in varying jurisdictions. Maintaining compliance visibility of these assets regarding both regional regulations (for instance Indian DGCA) and global regulations i.e. FAA and EASA is often challenging. Regulators routinely issue airworthiness directives, advisory circulars and safety notices to operators, alerting them to serious safety issues that affect assets. Furthermore, the manufacturers of the airframe, engines and components also issue their own airworthiness related advisories, applicable to the assets. In this study an engine lessor with a mixed fleet of narrow body and wide body engines in the fleet was seeking a scalable solution to address these points and to manage their assets from an airworthiness standpoint. The incumbent solutions in the market were primarily curated to suit a Continuing Airworthiness Management Organisation (CAMO), but not necessarily suited to a lessor who manages their fleet airworthiness in-house and on an ongoing basis.

Remedy

SPARTA's Airworthiness Management solution was designed and developed as a green-field application within its existing suite of solutions. The application had to fulfil a need for high specificity, addressing the needs of airworthiness monitoring, data analysis, data entry & updates, and forecasting of compliance regulations at both a task as well as asset level. The user experience was designed such that it ensured intuitiveness and ease of use while maintaining a strong commonality with the other solutions within the wider SPARTA platform such as Projects Management and Records Dataroom which complemented the Airworthiness Management application. Seamless integration was ingrained throughout the application such that the technical records of the assets achieved two-way accessibility from the dataroom as well as from the Airworthiness Management application. Lastly, customer requirements for customisations were also taken onboard to deliver a solution that fitted well with the customer's operations and business model.

Outcome

Within a span of only 2 months, the technical records for the entire fleet of assets were migrated from an FTP server to a fully online technical records solution, powered by the in-house records analysts and data management team. The airworthiness data for the assets was set up through bulk status sheet and report upload to establish a reliable updated system for use across the company's business verticals. Custom reports and change requests were addressed promptly with in-house expertise and developer prowess.
